A MORE EFFECTIVE DANISH DEVELOPMENT POLICY

FREEDOM FROM POVERTY - FREEDOM TO CHANGE

Freedom is a precondition for development. True poverty is the absence of freedom and ability to improve one's own situation. The fight against poverty must therefore be directed towards ensuring the poorest people freedom and ability to exploit the opportunities that freedom provides.

Promoting freedom is central to the **new strategy for Denmark's development cooperation**, "Freedom from Poverty – Freedom to Change". Through its development cooperation, Denmark will enable people to shape their own lives and contribute to changing the problems of endemic poverty, which for too long has been part of the global reality.

To realize this ambition, focusing and prioritisation is crucial. Developing countries face numerous challenges, but it is not realistic to believe that Denmark can help solve all these problems.

Danish development assistance will therefore be concentrated on fewer countries and sectors and tailored to the five priority areas in the new strategy for Denmark's development cooperation: 1) Freedom, democracy and human rights, 2) growth and employment, 3) gender equality, 4) stability and fragility, and 5) environment and climate. This will ensure that Denmark is active in areas where we can best make a difference; where we can achieve the best possible results and where we can contribute to setting the agenda. This ensures maximum impact and results of Danish development cooperation and a significant Danish contribution to the international endeavours to achieve the UN Millennium Development Goals.

RESULTS OF DANISH DEVELOPMENT ASSISTANCE MUST BE DOCUMENTED AND COMMUNICATED

The Government will maintain Danish development assistance at the level of DKK 15.2 billion annually over the period 2011-2013. In 2011, development assistance is expected to reach the level of approx. **o.84 per cent of Danish GNI**. With this high level, Denmark will maintain its position among the five countries in the world that meet the UN target of providing at least 0.7 per cent of GNI in development assistance.

The quality of Danish development cooperation must be of the highest standard. Aid effectiveness must be further increased and **the results of development assistance** documented, communicated and applied in new efforts. Clear targets will be set to measure progress in partner countries, and the measurement of results will be

strengthened. Denmark will therefore launch an internationally oriented research programme, focusing on what works in development cooperation. Danish NGOs will also be met with stronger requirements towards documentation of results, which will influence the level of the annual contributions they receive. **Efforts to communicate** the results of Denmark's development cooperation will be strengthened and the allocation of funds to information activities will be increased in 2011 and the years ahead.

FOCUSING AND PRIORITISATION

Danish development cooperation will be concentrated on fewer countries and each engagement will be more comprehensive. These countries will henceforth be termed **partner countries**. Partner countries are defined as countries where Danish presence is based on a long-term perspective and has political and financial weight. In 2011, Denmark will have 26 partner countries. This group includes the former programme countries and a number of other countries of cooperation, including fragile states. The main part of Danish development assistance will continue to be channeled to Africa.

Long-term development cooperation with national governments is the point of departure for Denmark's engagement in the majority of partner countries (15 countries). In other countries (11 countries), Denmark's development cooperation is based on partnerships with non-governmental or international actors operating in the country that are able to advance people's freedom as well as access to democracy and better living conditions. In 2011, the Government will allocate approx. DKK 3.6 billion to new programmes in partner countries.

Over the coming years, the Government will reduce by approximately 25 per cent the total number of countries, including non-partner countries, to which Denmark provides development assistance. During the coming years, the number of partner countries will be reduced from 26 to 15 to allow for an increased engagement in Africa and in fragile states. The phasing out of development cooperation with Nicaragua and Bolivia has been initiated in 2010, and the phasing out of development cooperation with Bhutan and Vietnam will continue as planned. In 2011, an extra DKK 200 million will be allocated to strengthening the efforts in African partner countries.

In partner countries, development cooperation will be focused on a few selected challenges. Denmark's support to education will be redirected by doubling the annual contribution to the World Bank's Education for All – Fast Track Initiative to DKK 270 million and by phasing out Danish bilateral assistance to education in Zambia, Benin, Burkina Faso and Nepal. The total Danish assistance to primary education will remain unchanged.

Focusing and prioritisation also applies to Denmark's **multilateral assistance**. The Government will give priority to those organisations which create results and where we

can best influence the political agenda. The Government will also strengthen the role of **regional organisations** and institutions in resolving the development challenges of partner countries, particularly in Africa.

PRIORITIES FOR DANISH DEVELOPMENT ASSISTANCE

Freedom, democracy and human rights

Respect for people's freedom and rights must be at the forefront of the dialogue with developing countries. The Government will strengthen efforts to build free, democratic societies and efficient public administrations which act to the benefit of its citizens. Therefore in 2011, DKK 895 million will be devoted to promoting freedom, democracy, human rights and good governance in Somalia, the Palestinian Authority, Burma, Iraq, Uganda and Tanzania. Furthermore, the Danish-Arab Partnership Programme will continue at the level of DKK 100 million a year to promote democracy and reforms in the Arab world. Finally, DKK 150 million will be allocated to various efforts to promote democracy and human rights in partner countries.

Growth and employment

Economic growth and employment in developing countries are prerequisites for poverty reduction. The Government will therefore significantly strengthen support for the development of the private sector in developing countries, based on among others the recommendations of the Africa Commission. Support for development of the private sector in Africa will be increased markedly towards 2014 in order to be able to guarantee DKK 2 billion annually to the private sector area as of 2014.

Every year, millions of young people in developing countries enter labour markets that are plagued by unemployment. This is a waste of resources. Therefore in 2011, DKK 50 million will be earmarked to strengthen **job opportunities** among youth in Tanzania and DKK 50 million will be earmarked to promoting private sector development during the reconstruction phase in Zimbabwe. Furthermore, DKK 225 million will be allocated to increase access to sustainable energy, particularly for the private sector in rural areas of Africa. As part of the implementation of the new strategy for Denmark's development cooperation, an extra DKK 50 million will in 2011 ensure that Denmark can launch new initiatives that create added value in all elements of the production chain, development of regional markets and trade.

Gender equality

Gender equality is a fundamental right. Women must be integrated into the economy and have the same opportunities and rights as men. The Government will maintain

and strengthen its active role in the promotion of gender equality and speak up for women in the dialogue with partner countries. In 2011, for example, DKK 430 million will be allocated to the health sector in Kenya to promote access to family planning, health information, modern contraception and general health services, especially in rural areas.

Support to the UN Development Fund for Women (UNIFEM) will be doubled to DKK 20 million in order to support the establishment of the UN Entity for Gender Equality and the Empowerment of Women. The purpose of the entity is to ensure that gender equality is incorporated into the work of the entire UN system. Besides that, support to the World Bank's Education for All – Fast-Track Initiative (FTI) will, as previously mentioned, be doubled to DKK 270 million annually. Here it is a key Danish priority that stronger emphasis is placed on girls' education. The annual contribution of DKK 165 million to, among others, the International Planned Parenthood Federation (IPPF) and of DKK 205 million to the UN Population Fund (UNFPA) will be maintained.

Stability and fragility

One third of the world's poorest people live in fragile states, which are those countries that are furthest away from achieving the UN Millennium Development Goals. Persistent conflict and instability impedes the fight against poverty and ultimately puts pressure on our own security. The Government will therefore give increased priority to efforts in fragile states. This requires willingness to defy the risk of fraud and corruption. At the same time, Denmark will maintain its zero-tolerance policy towards corruption. Mismanagement of Danish funds will continue to be vigorously investigated and punished.

Fragile states like Zimbabwe, Sudan, Somalia, Ethiopia, Pakistan, the Palestinian Authority and Burma will be partner countries as of 2011 and will receive support in 2011 totalling DKK 1,009 million. Cooperation with **Afghanistan** will be strengthened and DKK 515 million will be allocated to Afghanistan in 2011.

As part of the implementation of the Danish Defence Agreement for 2010-2014, DKK 65 million will be allocated to the new inter-ministerial **Global Framework for Integrated Stabilization Efforts** in e.g. Africa and the Afghanistan/Pakistan region. In addition, DKK 100 million will be allocated to special **stability and conflict prevention** interventions implemented by selected multilateral and international organizations, including enhanced civil capacity in military operations.

Humanitarian assistance will be increased to DKK 500 million in 2011. DKK 400 million thereof will be allocated to protracted humanitarian crises in seven partner countries: Afghanistan, Burma, the Palestinian Authority, Ethiopia, Pakistan, Somalia and Sudan. The high level of assistance to the regions of origin initiative totaling DKK 300 million will be maintained in 2011.

Environment and climate

Sustainable development in the poorest countries of the world cannot be ensured without an effort to resolve the environmental and climatic challenges that developing countries face. Integration of climate change concerns will therefore be an essential element of Danish development policy. In 2011, DKK 40 million will be allocated to regional environmental initiatives in Asia, and DKK 140 million will be allocated to a multilateral natural resources programme with special emphasis on climate change adaptation in the management of land and water resources. The Climate Pool, which is part of the Danish contribution to climate funding, will be increased in 2011 to DKK 400 million. The aim is to strengthen efforts to enhance framework conditions for climate initiatives of developing countries.

Appendix 1 illustrates that new sector programmes and other major programmes in 26 partner countries of approx. DKK 3.64 billion will be launched in 2011.

Appendix 2 gives a detailed overview of the Government's priorities for allocating development assistance over the next five years, 2011-2015.

Appendix 3 gives an estimate of total Danish development assistance in 2011 according to OECD/DAC rules.

The Danish Government hereby presents its priorities for Danish development assistance 2011-2015.

Promoting freedom is central to the new strategy for Denmark's development cooperation, "Freedom from Poverty – Freedom to Change". Through its development cooperation, Denmark will support efforts that enhance the freedom of individuals and their capacity to influence their own lives.

The strategy identifies five priorities: 1) Freedom, democracy and human rights, 2) growth and employment, 3) gender equality, 4) stability and fragility, 5) environment and climate. Danish development assistance will be targeted towards supporting development in each particular country the best way possible.

Denmark's development cooperation will be directed towards fewer countries and sectors, but with greater political and financial weight in each engagement. Henceforth, such countries will be termed partner countries.

Danish development assistance will also be focused on fewer multilateral organisations. The Government will give priority to those organisations which create results and where we can best influence the political agenda.

The Government will focus on increasing aid effectiveness and ensuring that results are documented and communicated.
